## Item 6.06/62 VISITORS' REPORT AND REPRESENTATIONS

- 6.1 The Panel received a paper for discussion/approval from the Executive.
- 6.2 The Panel noted that the MA Music Therapy programme at the Royal Welsh College of Music and Drama had been visited on 25-26 April. The Panel noted that the education provider had made representations about a condition in the Visitors' Report, which required that the medical studies component of module 1 should include teaching from a range of staff with relevant specialist expertise and knowledge in core health disciplines. The reason given for the condition was that the module was currently taught from a single discipline perspective and additional input was required to ensure that subject areas relating to human health, development, disability, mental health, normal and abnormal psychology, acquired and organic disorders, etc were taught by staff with a range of specialist knowledge and expertise.

- 6.3 The Panel noted that the education provider had explained that the module was designed to cover the study of medical conditions with which music therapy students would ultimately work. It was structured to cover the basic medical information the students might need in order to work safely and effectively with their client group. By having a same member of staff to deliver this module, it provided continuity and also a basis upon which fair assessment could be made.
- 6.4 The Panel noted that the education provider had explained the member of staff who taught medical studies was, by profession, an occupational therapist. The Panel noted the details of the member of staff's educational and health and social care experience. The education provider had stated that the subject areas suggested by the Visitors' Report were already taught.
- 6.5 The Panel received a copy of the information available to the Visitors on the visit (i.e. a Curriculum Vitae of the member of staff concerned and the module descriptor of the module concerned). The Panel felt that, given the information available to the Visitors at the time of the visit, they were right to recommend the condition against Standard of Education and Training 3.5. The Panel agreed to accept the report with the conditions. However, the Panel felt that the response from the education provider would be sufficient to meet the condition. The Panel agreed to encourage the Visitors to accept the representation as an adequate response to the condition and the reason given for it. The Panel noted that the Visitors would make a final recommendation on programme approval to a future Panel meeting and hoped that no further information would be required to meet the condition.

# Item 8.06/64 UNIVERSITY OF ESSEX - MSC SPEECH AND LANGUAGE THERAPY PROGRAMME APPROVAL

- 8.1 The Panel received a paper for discussion/approval from the Executive.
- 8.2 The Panel noted that the HPC had first visited the MSc Speech and Language Therapy programme at the University of Essex on 13-14 June 2005. The HPC had set a number of conditions at the visit. The education provider had made a response to the Visitors' report. The response and report were considered at the meeting of the Approvals Committee on 9 September 2005, which made minor amendments to the report.
- 8.3 The Panel noted that, in the process of meeting the conditions set out in the original report, the education provider had made what the Visitors considered to be major changes to the curriculum. This resulted in several of the original conditions being superseded and new issues being raised. The Visitors had recommended that a further Visit, on specific Standards of Education and Training, would be required to investigate the new curriculum and its impact on the programme.
- 8.4 The Panel noted that the follow-up Visit, which had involved the original Visitors, had taken place on 21 April. A new Visitors' report on the follow-up Visit had been prepared. The education provider had been given 28 days to respond to the report and had submitted documentation which had satisfied the Visitors that all conditions had been met.
- 8.5 The Panel agreed to accept the Visitors' Report for the visit undertaken on 21 April and agreed that the following programme should be approved as meeting the Standards of Education and Training:
