Executive Summary and Recommendations

Introduction

The HPC annual monitoring cycle involves two types of monitoring submissions (audit and declaration). Education providers have been divided into group A and group B. In 2007, all programmes that are in group B need to complete the declaration form. Education providers are expected to submit the monitoring submissions to HPC within 28 days of their institution's own internal annual monitoring process.

This paper is asking the Education & Training Panel to agree that those education providers listed below, who have successfully submitted an HPC annual monitoring declaration form, continue to be approved as leading to registration with the Council.

All declarations forms for programmes have been checked and confirmed by the executive. Declaration forms may be seen upon request.
