EXECUTIVE SUMMARY AND RECOMMENDATIONS

INTRODUCTION

The following is the relevant minute from the meeting held on 24th June 2004:

69.2 It was AGREED that there should be no payment for preparation time at present but that the allowance itself should be reviewed. It was agreed that an analysis of rates payable by similar bodies be prepared and our rates benchmarked against it. If the Committee then felt a change was necessary in the basic allowance, recommendation would then be made to Council. The Committee asked for the information to be available for the September meeting.

An analysis has been undertaken of rates paid by the other regulators whose work comes under review by the Council for Healthcare Regulatory Excellence (CHRE), formerly CRHP.

The Committee is asked to consider:

whether any changes to attendance allowance rates should be made now or at the start of the next financial year

and

to confirm that the decision not to pay for preparation time should stand.
