MINUTES of the second Fitness to Practise (FtP) Forum held at 10.30am on
Wednesday 23 April 2008 in the new Council chamber at Park House, 184 Kennington

Item 1.08/01 Apologies for absence

- 1.1 The Chairman welcomed members and other attendees to the meeting.
- 1.2 Apologies were received from Mrs P Blackburn, Mr R Clegg, Professor D Waller and Mr M Woolcock.

- 2.1 The following papers were tabled by the Executive to support items already on the agenda:

Minor changes to the practise note were submitted to be cleared in order that it could be put to use immediately instead of waiting for the September meeting.

- 3.1 It was agreed that the minutes of the first meeting of the FtP Forum (the Forum) should be confirmed as a true record and signed by the Chairman.

Item 4.08/04 Matters arising from 12 September 2007 FtP Forum

- 4.1 The Forum received a paper to note from the Executive detailing the actions agreed during the first meeting on 12 September 2007.
- 4.2 The Forum noted the completion of the agreed actions.

Item 6.08/06 Director of FtP report

- 6.1 The Forum received a paper from the Executive with the details of FtP decisions made between January and March 2008, and of significant other meetings and work undertaken by the department in this time.
- 6.2 The committee noted that the completion of the case management team and a Freedom of Information Act 2000 (FoIA) case brought before the Information Commissioner tribunal were the most significant developments for the FtP Department since the FtP Committees met in February.
- 6.3 The Forum noted the report.

Item 7.08/07 External review of complaints literature

- 7.1 The Forum received a paper from the Executive introducing a report, which had been commissioned by HPC in October 2007, into existing research on complaints mechanisms by Dr J Gulland of the University of Strathclyde.
- 7.2 The Forum was asked to:
1. consider the report;
 2. approve the publication of the report as an HPC monograph;
 3. consider:
 - a. whether and, if so, how to take this research forward;
 - b. the issues to be addressed by any further research; and
 - c. the issues which may need to be addressed by the FtP Department arising from the research.
- 7.3 Dr Gulland presented the report, explaining that findings had been separated into four areas:
- barriers to complaining
 - satisfaction with complaints procedures
 - types of complaint
 - examples of good practice
- 7.4 As a conclusion Dr Gulland recommended the following areas for possible future work, and then invited comments from the Forum:

- Overlap between different complaints mechanisms
- Expectations of complainants
- HPC specific barriers to complaining

- 7.5 The Forum commended Dr Gulland for the quality of the report.
- 7.6 The Forum noted that complainants may have seen the negative consequences of a loss of anonymity during a complaints process as a barrier to complaint. There was evidence to suggest that this loss of anonymity did have an impact in certain professions. There was a significant amount of literature to support this view. The Forum noted that the social class of a complainee was likely to have had a significant impact on their likelihood of complaining and that the National Consumers Council had conducted research in this area.
- 7.7 The Forum noted that expectations held about an organisation were critical in reaching a decision about whether or not to make a complaint. The expectations of HPC held by registrants were a challenge that could be addressed by future work.
- 7.8 The Forum noted that local determinants of access to service were critical when developing an approach to complaints management. There was not a standard method for determining the responsibility for dealing with complaints in different sizes and types of professional environments.
- 7.9 The Forum noted that the report did not provide evidence of barriers to complaint which were specific to HPC. The Forum noted that that data would need to be collected for another year before it could be analysed for trends.
- 7.10 The Forum noted that the research demonstrated that the HPC's FtP data was the most comprehensive data available on complaints about the HPC's registrant professions and further research on this database might be valuable.
- 7.11 The Forum recommended the following to the FtP Committees:
1. To approve the publication of the report as a HPC monograph.
 2. That the Director of FtP should be asked to return to the Forum with a proposal for further action.

Item 8.08/08 FtP annual report 2007-2008

- 8.1 The Forum received a paper from the Executive inviting it to consider the draft FtP annual report 2007-2008 and recommend to the FtP Committees that they recommend that the Council approve the document.

8.2 The Forum noted that there had been an increase of complaints made by registrants although the total number of complaints remained comparatively low. The Forum noted the FtP Committee Panel decisions. The Forum noted the extra information on proposals for work in the next year.

8.3 The Forum had the following suggested amendments to the draft report:

- Charts 1.2 and 2.2 describe similar subjects, and should be the same type.
- The data in graph 1.4 on complaints by profession would be better displayed in a series of pie charts.
- The Convictions section on page 15 should explain whether those found to have convictions remain registered.
- Table 5.2 should be titled "Summary of hearings when allegations are found proved."
- Title on page 49, "Review hearings" to be changed to "Review of conditions of practice orders".
- Statistics should not be derived from small numbers and included in charts.
- Pie charts should be used with caution as they do not show trends.

8.4 The Forum noted that there was no information about abuse of title in the draft report. This was Council business, and would have been more appropriately addressed in that section.

8.5 The Forum recommended the following to the FtP Committees:

To recommend to the Council that it approve the FtP annual report 208-2009 subject to editorial amendments.

Item 9.08/09 Equality and diversity scheme demographic data reports

9.1 The Forum received a paper from the Executive inviting it to consider the demographic data collected during the first year of the HPC equality and diversity scheme and asking it to recommend the following to the FtP Committees:

1. Data is collected from registrants and complainants for a further one year and;
2. A report is provided to the FtP Committees in April 2009.

- 9.3 The Forum recommended that the FtP Committees approve the following resolutions:
- That data is collected from registrants and complainants for a further one year and;
- A report is provided to the FtP Committees in April 2009.

Item 10.08/10 Case to answer practice note

- 10.1 The Forum received a paper from the Executive introducing a practise note intended to provide guidance on "case to answer" determinations by Investigating Committee Panels. The Forum was invited to discuss the practice note and recommend that the Investigating Committee approve said practise note.
- 10.2 The Forum noted that there is an intention to produce a plain English version, and a flow chart to help registrants understand the process.
- 10.3 The Forum recommended that the Investigating Committee approve the practice note.

Item 11.08/11 Preliminary hearings practice note

- 11.1 The Forum agreed to take the tabled paper FtP19/08 at item 11 as it was similar to the case to answer practice note item, and would be presented by the same official.
- 11.2 The Forum received a paper from the Executive introducing amendments to the practise note on preliminary hearings by FtP Committee Panels. The Forum was invited to discuss the amendments and recommend that the FtP Committees approve the practice note.
- 11.3 The Forum had no comment to make on the draft.
- 11.4 The Forum recommended that the FtP committees approve the practise note.

Item 12.08/12 Equal treatment practice note

- 12.1 The Forum received a paper from the Executive introducing amendments to the practice note on equal treatment by FtP Committee Panels. The

Forum was invited to discuss the amendments and recommend that the FtP Committees approve the practice note.

- 12.2 The Forum noted that the changes made to the practice note were not substantial and were in line with legislation.
- 12.3 The Forum recommended that the FtP Committees approve the practice note.

Item 13.08/13 Internet social networking

- 13.1 The Forum received a paper from the Executive inviting it to discuss advice from the solicitors, Bircham, Dyson, Bell on the issue of how information from social networking sites such as Facebook should be dealt with at the case to answer stage of Investigating Committee Panels. The Forum was invited to recommend that the Investigating Committee approve the incorporation of the advice into FtP operational guidance.
- 13.2 The Forum commended the work, noting that it added clarity to the distinction between what is public and what is private space.
- 13.3 The Forum noted that the focus of changing the guidance had been on misconduct, for instance on breaking patient confidentiality, and not directly about the validity of using the internet in work time for personal purposes.
- 13.4 The Forum recommended that the Investigating Committee approve the advice and its incorporation into operational guidance.

Item 14.08/14 CHRE guidance on clear sexual boundaries

- 14.1 The Forum received a paper from the Executive providing background to the work undertaken by the CHRE project group on guidance on sexual boundaries, how this relates to HPC work in this area and how the Executive proposes to implement the recommendations from the documents relevant to HPC. The work was undertaken in response to a request by the April Health Committee.
- 14.2 The Forum noted the report.

Item 15.08/15 Panel/legal assessor feedback forms for FtP Committee Panels

- 15.1 The Forum received a paper from the Executive inviting it to note feedback forms which are being introduced at Conduct and Competence and Health Committee Panels. The forms are designed to be completed
